

#### Steven Kordalski, FAIA

Throughout my career I have always used constraint to create simple, elegant solutions to interior architecture and small-scale projects normally not elevated through design. I work hard to uncover the true design potential within ordinary projects to make the mundane magical. Over the years while focusing on maintaining a boutique design oriented architectural firm, I have never forgotten the importance of involvement, leadership, service and mentorship within and outside the office.

BACKGROUND Steven Kordalski, FAIA, a native of Cleveland, Ohio, founded Kordalski Architects Inc. in his hometown in 1984. Steve is a respected voice for modern design within a region where modern ideas are not always welcome and accepted. He elevates the role of architect from specifier to collaborator, teacher and mentor. Steve has proven over 38 years a small firm can sustain itself while at the same time producing high level design by uplifting common projects.

Much of Steve's work has been completed in a region where it would be easy to "just get a building permit" and yet his projects exceed expectations. Most of his work is centered on Architectural Interiors. Throughout the years he has also brought strong design skills to residential, small commercial, joint venture and preservation projects. Steve educates clients regarding the value of design rather than allowing them to accept mediocre solutions. Throughout his career Steve has always believed quality design should not be reserved for large expensive commissions but rather for projects of all scales. Through his design work he has helped Interior Architecture become a design specialization equal to Historic Preservation and Urban Design within the profession.

**DESIGN / WORK THOUGHTS** Steve's work is approached as a careful calculated search for perfection no matter the size of the project. Whether an Architect-designed birdhouse for an AIA exhibit / fundraiser, a corporate interior, or the renovation of the 1880's Old Stone Church, each project is treated with the same care. Completed projects are always a direct result of the implemented design process – a long sequence of elaboration and refinement through all project phases.

Most of Steve's work is not on stellar commissions. Over the years he has demonstrated that quality design can occur at all scales and within limited budgets. A constant theme throughout completed projects is resourcefulness. He manages strong concepts with modest materials to create refined results. Projects are rooted in the culture of the client with solutions tailored to their needs. His work has been summarized as "minimalist with soul."

His office has remained small – between 2 - 3 total staff. It has always operated as a studio atmosphere where sketching and physical models are promoted as study tools. His belief has always been that the process is as important as the result. In the age of specialization Steve is a "Renaissance man." He participates in every project phase from early design through construction administration. As the owner of a boutique firm, he is involved all aspects of the business however Steve has never shortchanged the design process. His finished work demonstrates that care.

**MENTORSHIP** Another passion of Steve's is mentorship. His belief in openness is driven by the idea – "how can the profession improve if I don't share information?". His mentoring occurs in the office, with students, in both formal programs and casual conversations. Past employees are spread across the country whether in graduate schools, running their own offices, teaching, or employed in other firms. Steve has played a part in helping them reach their goals. His mentor messages are now distributed nationally from Rhode Island (RISD) to Hawaii and cities in between.

He was invited to join the AIA Cleveland Board as the Kent State University College of Architecture and Environmental Design Liaison. In 2017 he implemented a yearly scholarship program for a KSU CAED student that excelled within their AIAS Chapter. In 2021, Steve was instrumental in converting the initial scholarship to a \$40,000 endowed scholarship. He initiated a KSU CAED AIAS meet and greet program that introduced students to practicing professionals from 3 AIA Chapters. In the initial two years of the event over 200 students participated. He has been involved in AIA Cleveland's organized mentorship program since its inception in 2015. Steve's paying it forward skills have been felt across the country as students and mentees relocate.

**DESIGN RECOGNITION** Steve has been invited to participate on eleven AIA Design Award juries including the 2018 AIA National Small Projects Design Awards Program. He has participated on three International Illumination Design Awards juries. Twice Steve co-chaired the AIA Cleveland Design Awards program. He raised over \$65,000 in sponsorships for the celebrations. Through his help, the event was transformed from a small program to a gala event attended by over 550, led by prominent Jury Chairs. He secured Jury Chairs that brought a national presence to AIA Cleveland.

Over the years Steve's work has received numerous AIA Design Awards. Juries from across the country have recognized the quality of Steve's work. In 2012, he received the prestigious Cleveland Arts Prize for Design – the nation's oldest municipal arts award. In 2014 his firm was awarded the AIA Ohio Gold Medal. In 2019 Steve received the AIA Ohio Mentorship Award, and in 2021 he was one of four selected to receive an AIA National Design Grant Award. Steve was elevated to the College of Fellows in 2022 in Object One: Design. It is extremely rare for an owner of a small firm to receive these recognitions.

Throughout his career Steve's passion, commitment to design, leadership and service have established examples for others to follow.

**Challenge | Outcome Statement:** Originally the client wanted an extremely traditional office space – in their words "a roman bathhouse look." Steve educated the client and together they created a modern solution that transformed their workplace culture.

The top floor (57<sup>th</sup>) of Key Tower in downtown Cleveland had not been leased in the buildings 16-year history. AT&C, an intellectual property attorney, determined in order to create the required densities, individual work areas would be modest in size compared to other attorney's offices, however individual offices would have spectacular views. Since the program dictated an extremely concentrated private office use, the potential for a maze of corridors existed. Everything from the initial planning to detailing reduced the corridor feel and created vistas while expanding the space. Once completed AT&C became the highest office space between New York City and Chicago.



**Challenge | Outcome Statement:** Enhance the mundane experience of having a key duplicated or a lock repaired. Steve executed a solution using inexpensive materials to establish a new model for a key shop.

The client requested the key shop be brought into the future in terms of design, while maintaining the vocabulary of a traditional working key shop. A traditional "front door" street entry was maintained with the primary customer entry located off the rear parking lot. One of the major elements defining the space is the retail counter clad in corrugated metal. A pegboard cabinet spline separates the key prep and locksmith area from the retail counter. All key blanks and key machines are housed on the public side of this spline to allow the customers to view the cutting of a key. Storage and work counters are then located on the key prep side of this spline. The retail area organizes the storage gondolas around an undulating wall that surrounds pegboard storage panels. The three separate areas are tied together with caged light fixtures hovering above the lower elements that separate the space.






Challenge | Outcome Statement: Ten Capital Managements first office space needed to establish their undefined workplace culture. Collaborating with the client Steve created an open and transparent office environment within a 2440 sq. ft. landlocked space.


Conceptually, an alternate suite entry location was developed rather than the building owner's proposed entry from the common corridor. This created 1.) a private entry area specifically for this tenant, 2.) organized the separation between entry, work area and support functions, and 3.) created a suite midpoint entry with multidirectional views. A thickened purple venetian plaster wall further defines the separation of the public spaces from the actual staff/partner workspaces. The three partner offices, the conference room and entry all have floor to ceiling glass helping to expand spaces into one another. The ceiling heights were set as high as possible to create a volume within the office. Tenfoot high white oak doors help to accentuate the height. A slightly lower ceiling plane defines the public entry and slides through the reception area terminating and folding down the far conference room wall. Besides white oak millwork, desks, credenzas and tables were all custom designed. Furniture tops and waterfall returns are 2 ½" thick that mimic the ceiling planes.



**Challenge | Outcome Statement:** Create an Italian restaurant that avoids the typical theme stereotypes. Steve used a strong spatial organization along with a limited material pallet to avoid those cliches.

Paul Minnillo, an established restaurateur in Cleveland, Ohio, wanted to open a casual contemporary Italian restaurant. The new strip center (designed by another architectural firm) where this restaurant is located had been vacant for almost three years. Since the building shell was existing, certain elements within the floor plan, such as the entry vestibule, exit doors, etc. were already defined, located and therefore incorporated. Conceptually, the open kitchen, wood burning pizza oven and bar were to be the center of the restaurant. Dining rooms generate out from this central area. The plan is divided into the bar area and a main dining area. The customer is immediately visually connected to the open kitchen as they enter the restaurant. A triangular mass made up of the wine closet, coat closets, and storage, in conjunction with a casual lounge soft seating area, separate the two dining spaces. Ceiling planes help draw customers in, while at the same time defining specific spaces. Stainless coil drapes screen views while creating privacy.


**Challenge | Outcome Statement:** Establish a new workplace culture for an accountant's office while maintaining the required security. Through a strongly organized plan, Steve created a light filled open environment while respecting the client's privacy concerns.

Zinner & Co., an accounting firm, had been in their current office space for twenty-five years. Their existing offices were extremely outdated and very "private office oriented" creating a maze of corridors. Once they determined to relocate offices, they also decided to adjust their workplace culture. The private office to workstation ratio became 1/3 private offices – 2/3 workstations, allowing for open areas rather than corridors. Due to the confidential nature of their business, they wanted a strong sense of public vs. private spaces that maintained the required security.

Conceptually, the initial idea was to create a strong public area made up of a reception space and three conference rooms. Enclosing the conference rooms with glass created extended vistas in multiple directions when entering the space. When arriving on their multi-tenant floor, exterior views are exposed through the conference room and reception space directly to the elevator lobby. Private offices have floor to ceiling glass fronts, in combination with full height doors. The glazing units are made of a top and bottom 24" clear panel with a white interlayer panel screen with clear aluminum frames. The clear panels allow spaces to expand into one another while the white screen creates the privacy important to this industry. This glass combination allows natural light to penetrate the interior spaces.

**Challenge | Outcome Statement:** Create a modern barbershop that would appeal to college students. Borrowing from old traditional barbershops, Steve reinvented those familiar elements in a modern vocabulary within an extremely tight budget.

This small barbershop was created by completely gutting and remodeling an existing 15' wide storefront within a 65-year-old mixed-use building. The space is located adjacent to Case Western Reserve University. By combining traditional barbershop concepts with modern overtones, the space appeals to the college clientele. The program consists of a cutting/shampoo area, an ADA restroom, a small office, and a laundry / utility room. The buildout was completed under an extremely tight budget of \$46,500.

Like traditional barbershops, a mirror hangs at each cutting station. A large mirror hangs over the seating area opposite the stations. The images created between the mirrors are not only functional but also expand the 15' wide space. The layering and alternating of the translucent screen and the existing glass storefront lets natural light deep into the interior while allowing the clientele to experience the "street and sidewalk movement" without appearing to be on display. The translucent panels are repeated horizontally to reduce the scale while visually masking mechanical ductwork. Both the horizontal / vertical panels are backlit to create unique custom light sources. The patterns and colors created by the refraction of light adds movement and depth to the panels.





**Challenge | Outcome Statement:** Create a new fresh workplace for an established firm in a small landlocked leftover empty space. By organizing the plan around a great hall space, Steve created an open environment with extended views while completely redefining the client's workplace culture.


**Project Information:** The client, three partners of a boutique investment firm, had decided to relocate their offices. At the same time, they wanted to create a new modern working environment. Their program consisted of three private offices, one workstation, reception area, conference room, open area casual meeting spaces and a workroom/data room. They settled on a small space that was landlocked between two existing leased office spaces.

The finished space potentially could have had a "bowling alley" affect. Care was taken to avoid that type of solution. Offices and support rooms were organized around a great hall space that is anchored at both ends with full height glass. Within that great hall space, waiting, reception, lounge and common areas occur. Interior office materials slide through the recessed entry helping draw guests into the great hall from the common corridor. Upon entering the office, the visitor is greeted by a reception desk backed by full height acid etched glass panels that diffuse views. The acid etched glass is also strategically repeated throughout the office within the sidelight frames. White oak storage cabinetry millwork slides through the different spatial functions. Halfway back, the space widens creating multi-directional views through the all-glass fronted conference room. An office, the conference room, and entry common corridor all have floor to ceiling glass helping to expand spaces into one another. This also lengthens visual sightlines from space to space and directly to the exterior. Borrowed natural light comes deep into the space. In the office and conference room, a sheer curtain provides visual privacy when required. The ceiling heights were set as high as possible to create a volume within the office. Ten-foot-high white oak rift cut doors in clear aluminum frames help to accentuate the height. A slightly lower silver metallic painted drywall ceiling plane defines the public entry. It begins outside the space, slides through the reception area, and terminates at the office glass wall. White oak millwork repeats the theme of the doors.

**Challenge | Outcome Statement:** Helping individuals establish their own career path and gain the confidence to exceed their own expectations and goals. Steve feels these individuals are an extension of his practice - a landscape architect in Philadelphia, an associate professor at RISD, a partner in an office in Fort Myers, an owner of a firm in Honolulu, senior associates in NYC and Boston, a sculptor in Minneapolis and several employees in Cleveland / Akron. These mentees have gone onto have successful careers and represent the profession well throughout the country.

#### **Cleveland Connect AIA Mentorship Program 2015 - Present**

AIA Cleveland's mentorship program started in 2015. When mentoring within this program, the mentee and Steve schedule quarterly meetings at a minimum. The mentee always directs the discussion direction.

#### Informal mentor | mentee participants

This group of mentees grew out of involvement and participation. At some point, each mentee reached out to Steve seeking advice. These relationships have grown over the years and continue today. Steve is confident that these mentees will (if not already have) become great mentors.

#### Planting the seed programs

These are examples of involvement / participation events that Steve helped initiate. These events establish relevance and begin conversations that help open doors. Events such as these show students, interns and young architects that professionals are approachable and care. They begin to get the mentorship ball rolling.

#### AIA Cleveland Board Member 2016 - 2018

Role: Kent State University College of Architecture and Environmental Design Liaison AIA Cleveland's relationship with KSU CAED was almost nonexistent. Steve saw an opportunity to correct that situation. With the opening a new building and a new director the timing was perfect. Due to Steves efforts AIA Cleveland and KSU CAED's relationship is the strongest it has ever been.
