#### AIA Ohio Annual Meeting Report

#### Government Relations Report

Administrative: OFCC Forms and Legislation. The Ohio Facilities Construction Commission is revising front-end construction contracts, including the Design-Build and Construction Manager at Risk documents. These are significant revisions. Design Professionals engaged in these delivery systems might participate in the dialogue.

OFCC anticipates adding legislation to the Operating Budget, which is not typical unless all interested parties agree. OFCC is holding meetings to review concepts such as revision of the Qualifications-Based Selection law, which will affect every public subdivision across the State.

The working group came to consensus on Retainage Reform, which will be of particular interest to both prime contractors and subcontractors.

<u>Legislative Session</u>. The Ohio General Assembly left Columbus to return to their home districts, to campaign for the November 5th General Election.

Issue 1 is the anti-gerrymandering initiative on the ballot, which if passed excludes legislators and partisan officials from re-drawing legislative lines. The Ohio Ballot Board, controlled by Republicans, adopted language inaccurately describing Issue 1 as intended to "Establish a new taxpayer-funded commission of appointees required to gerrymander the boundaries of state legislative and congressional districts…".

Before departing, the legislature sent the Capital Appropriation bill to the Governor who signed it the next day, effective immediately. House Bill 2 sends \$4.2 billion to localities for the next biennium, in the largest such appropriation in Ohio history. Both Republicans and Democrats voted for the bill, with at least one construction project designated in each legislator's district.

The House and Senate set their "lame duck" schedule after the Election, with only four Senate dates in November, and the House not returning until December. The final dates before Christmas include only six days "if needed".

In the last two years, the General Assembly passed fewer bills than in any recent biennial session. Pending bills which affect the Construction Industry include:

House Bill 203, establishing "prompt payment" penalties for the untimely payment of contractors in the private sector. The legislation passed the House by a wide margin, but may run out of time in the Senate after only one hearing.

After a decade of attempts, House Bill 129 also passed the House by a significant

margin, but awaits two more Senate hearings to require a commercial roofing contractor to hold a state license.

Senate Bill 41 passed the Senate unanimously to provide for expedited appeals to the Ohio Board of Building Appeals, and received four hearings in the House Economic and Workforce Development Committee, with no testimony most recently. Its status is unclear, but may pass the House in the last session days.

House Bill 327 passed the House with significant opposition from the Construction Industry, to require persons holding public contracts in construction to register employees for immigration purposes. Referred to the Senate General Government Committee, it appears likely to stall before further Senate action.

House Bill 497 passed unanimously to exempt county improvement projects for minor repairs from the requirement to obtain detailed plans, specifications, and cost estimates from an architect or engineer. The legislation also raises the QBS exemption from \$50,000 to \$75,000 related to the county notice requirement for purchases, leases, and construction contracts. Enacting a new section R.C. 307.901, the proposed law prohibits certain typical terms in a contract entered into by a county authority for the procurement of goods or services, such as retaining an architect, which terms otherwise are void ab initio. The bill has yet to be assigned for consideration by a Senate Committee.

The AIA Ohio GAC meets weekly via Zoom, on Mondays from 12:00p to 1:00 pm. If you would like to join the Committee and work on any of the legislative issues noted here, or would simply like to bring any issues or concerns to the GAC, please contact Kate, Karen or Dave.

#### 2025 Ohio Advocacy Day at the Statehouse

- The advocacy committee has started planning for next year's Advocacy Day at the Statehouse, which is currently for planned for March. Because 2025 will welcome a new General Assembly, the program will be held later than in past years, to allow for the organization of the legislature.
- The format for next year's program will be similar to 2024, with a potential change in venue.

#### AIA Ohio Affordable Housing Task Force created

 The Government Advocacy Committee has created the AIA Ohio Housing Affordability Task Group, to address issues of housing throughout the state. This task group, which meets monthly, has been working to establish its mission and strategic goals as it begins to seek members from across the state.

#### **OFCC / AIA Design-Build Contracts**

- The GAC met with members from Cincinnati, Columbus, and Dayton to review concerns about
  extensive modifications being made to AIA Standard Owner/Architect Agreements for school
  construction projects that are completed without state funding. AGC has similar concerns with
  Owner/Contractor Agreements for school projects.
- The GAC discussed strategies for addressing the concerns.
- The GAC recommended a workgroup be formed to work on the issue. Formation of the group is pending the identification of a member willing to chair the workgroup. Allison McKenzie has agreed to serve as the liaison between the GAC and the workgroup.

#### **OFCC/ Industry Partners**

• Members of AIA Ohio have been meeting with the Ohio Facilities Construction Commission to review proposed changes to how the OFCC operated. The OFCC has proposed several changes regarding the way they manage projects and thresholds established under law. The OFCC is working to shorten the process of hiring design professionals or contractors and the proposed changes are focused on those efforts. AIA Ohio, along with our AIA Ohio lobbyist, will continue to work with the OFCC to provide feedback on the changes. The OFCC is looking to include the proposed changes in the 2025 Operating Budget.

#### **Residential Building Code Revisions**

• AIA Ohio has had early discussions with the Ohio Board of Building Standards on changes to the Residential Code of Ohio (RCO). The Board of Building Standards has initiated the process this year with the Residential Construction Advisory Committee. This committee makes recommendations on changes to the residential code to the Board of Building Standards. Once reviewed by the Board of Building Standards, the Board will seek input from stakeholders on the proposed changes. This is where AIA Ohio will become involved in the process. It is anticipated that sometime after the first of the year, the initial set of revisions will be made available for review. AIA will review these changes and make recommendations, propose revisions, or accept the proposed without comments. More information will be made available once the proposed changes are released to the stakeholder.

#### **Single Stair Access Design**

Earlier this year, AIA Ohio was approached by the Lt. Governor's Office of Common Sense
Initiatives. A subgroup of AIA Ohio has been working on the proposed inclusion of Single Stair
Access, or Block Point Access, in apartment complexes of limited units and limited height. The
subgroup has had discussions with the Office of Common Sense Initiatives and staff of the Ohio
Board of Building standards as well as experts in this concept from around the country. AIA Ohio
has prepared comments to proposed OBBS standards and will soon be submitting this response to
the state. It is hoped that action will be able to be taken on this issue prior to the end of the year.

#### **AIA Ohio Legislative Member Survey**

AIA Ohio has developed a legislative survey to help the Government Advocacy Committee address
issues that the committee may see in the upcoming legislative session. The survey seeks input on
many areas of architecture and architectural issues. To be released to all AIA Ohio members soon,
this will help the Government Advocacy Committee, along with the Board of Directors and our
lobbyist, formulate responses to agency rules or legislation proposed. AIA Ohio would like to see all
members respond to this survey.

#### **AIA Ohio Political Action Committee (PAC)**

• The AIA Ohio PAC has seen moderate success this year as PAC continues its efforts to raise money in support of AIA Ohio's legislative agenda. The PAC funds raised from individual members are used to support legislators who align with the issues and concerns of AIA Ohio. Under Ohio law, the PAC can only accept contributions from individual members, and PAC monies cannot come from membership dues. The PAC is anticipated to become a more important tool for AIA Ohio as we move into the 136<sup>th</sup> General Assembly next year. New bills introduced after the first of the year will have two years to maneuver through the legislative process. AIA Ohio is making plans to initiate a more effective PAC campaign in 2025.

#### **Interior Design Legislation**

- AIA Ohio has noticed an uptick in national messaging around the benefits of Interior Design legislation.
- Several states have adopted new laws and related procedures to allow a variety of scenarios, including certification (title acts) and full licensing (practice acts).
- We have engaged AIA members from other states with experience in this topic and are tracking current legislation in neighboring Pennsylvania, among others.



# Treasurer's Report – November 6, 2024 By Dave Robar, AIA

The AIA Ohio three-year Strategic Plan, developed in November, 2021, outlined programming and services that we believed would add value to membership while advancing our mission of advocating for the profession. AIA Ohio's Board continued this year to craft a budget and financial plan that reflected the priorities outlined in the strategic plan. Throughout its history, AIA Ohio leadership has planned and saved for difficult times and because of that, AIA Ohio remains strong and well positioned to face the uncertainties of 2025 and beyond.

This chart illustrates at Sept. 30, 2024, AIA Ohio's funds compared to our annual budgets proposed for 2025 and 2026.



#### A few notes about this chart:

- Convention Reserves were set aside over time and specifically designated by past boards to be available in the event that a convention would not be financially successful. The last time funds from this account were expended was in 2021, when AIA Ohio paid AIA Dayton \$5,500 from this fund. The 2020 Convention was scheduled to take place in Dayton before it was cancelled for the pandemic.
- Investments have grown over time. AIA Ohio has not added money to this investment account in over ten years. Ten years ago, AIA Ohio investments totaled \$326,755.

#### **AIA Ohio Budget Proposal**

The 2025-26 budget proposal has been prepared and discussed by the Budget & Finance Committee, who worked with Kate Brunswick, CAE, Hon. AIA. The 2025-26 budgets were approved by the AIA Ohio Board in September.

AIA Ohio breaks down Revenues into five categories:

<u>Dues</u> – AIA Ohio collects three types of dues: Architects, Associates and Supplemental, or Firm dues.

<u>Programs</u> – Revenues from programs include the statewide conference, online firm profiles, the Design Awards Program and AIA Ohio's affinity programs for website advertising and workers comp insurance.

<u>Sponsorships</u> – The sponsorship program was amended this year to offer more flexibility to sponsors to receive the benefits they find valuable.

<u>AIA Revenue Share</u> – This represents the funding AIA Ohio receives from National.

<u>Transfer from Reserves</u> – This represents funding for special projects that AIA Ohio budgets to pull from Reserves in order to balance the budget.

AIA Ohio breaks down Expenses into five categories:

<u>Administration</u> – This expense includes the management fee, insurance, supplies/storage, postage, printing and copies, telephone expenses, and miscellaneous administrative expenses.

<u>Programs</u> – This includes expenses for the online firm profile, member communications, AXP coordinator, Associates programming, Statewide conference, the Design and Honor Awards programs, CARES Grants, the Foundation dues assessment and Marr contribution, the schools competition, and the AIA Ohio Digital Lending Library.


<u>Governance</u> – Included here are expenses for AIA Ohio's Representative to the Strategic Council, the National Associates Committee, the Young Architects Forum, AIA Ohio board meetings and strategic planning sessions, and expenses to send AIA Ohio leadership to National Convention, Leadership Summit and the CACE Annual Meeting.

<u>Advocacy</u> – This expense includes lobbying, legislative expenses, AIA Ohio's Day at the Statehouse, and expenses to send leadership to the State/Local Government Network meeting.

**Bank Fees/Accounting** – this includes credit card charges, bank fees, bank reconciliations and the annual audit.

# 2025 and 2026 Budgeted Revenues and Expenses





#### **Overview of 2025-26 Budget Recommendations Regarding Income**

Member Dues: The 2025 budget reflects 1,500 paid architect members and a 3.2% CPI increase, bringing AIA Ohio architect dues to \$151.27. The 2026 budget reflects 1,550 paid architect members and a 2.9% CPI increase, to \$155.66. These dues amounts reflect the dues assessment contribution to the AIA Ohio Foundation, which is \$18.06 of the 2025 dues amount and \$18.58 of the 2026 dues amount.

Associate Dues: The 2025 budget reflects 300 paid associate members and a 3.2% CPI increase, bringing AIA Ohio associate dues to \$64.70. The 2026 budget reflects 300 paid associate members and a 2.9% CPI increase, to \$66.58. These dues amounts reflect the dues assessment contribution to the AIA Ohio Foundation, which is \$11.79 of the 2025 dues amount and \$12.13 of the 2026 dues amount.

*Sponsorships:* Annual revenues from AIA Ohio Sponsor partners. A revamped sponsorship program in 2024 generated revenues in excess of budget.

*State Convention:* Budgets for 2025 and 2026 includes a statewide conference. Plans for 2025 include an event in September in Columbus.

AIA Revenue Sharing: AIA is revising the revenue share program again, effective 2025. The total amount to be distributed won't exceed 5% of the AIA budget, which has been reduced by over \$13m. Per the Ohio MOU, AIA Ohio's share of each of National revenue sharing disbursements is 10% - the remainder is split between Ohio's seven local components.

#### **Overview of 2025-2026 Budget Recommendations Regarding Expenses**

Administration: AIA Ohio signed a new contract with Accent on Management for association management services, effective 2025-2029. Lobbying was removed from this contract beginning in 2025.

Audit/Accounting: Per the AIA Ohio bylaws, we are required to conduct an annual audit each year.

Foundation Dues Assessment: This is money collected through the dues invoicing process on behalf of the AIA Ohio Foundation.

Legislative: Based on anticipated activities.

Member Communications: includes AIA Ohio newsletter, weekly email service, and web site maintenance.

*NAC, YAF and Strategic Council Representative:* The 2025 and 2026 expense budgets for this will fund these individuals to attend national meetings.

Annual Convention: Budget for a statewide AIA Ohio Annual Conference in 2025 and 2026.

National Convention and Leadership Summit: The budgets reflect sending the AIA Ohio President, President-elect and Executive Vice President to these events.

The Organizational Vitality Workgroup focused on updating AIA Ohio's contract with Accent on Management. This included extensive research and discussion regarding the scope of work required from AOM for AIA Ohio, the AIA Ohio Foundation, and the Ohio Architects PAC. Significant work was done to clarify the relationships between the entities and ensure this was reflected in the new AIA Ohio contract with AOM. In addition, lobbying was removed from the AOM contract, resulting in AIA Ohio contracting directly with a lobbyist.

It should be noted that AOM restructured its fee, bringing AIA Ohio's management expenses more into alignment with the income from membership.

The new AIA Ohio – Accent on Management agreement was executed in July, 2024, and will be in effect for 2025 – 2029.

#### AIA Ohio Public Awareness Work Group Report

The public awareness work group tackled a few topics for 2024:

- 1. Reviewed the Honor and Design Awards programs and provided suggestions for enhancing the programs. One suggestion is that Honor Awards be open to anonymous nominations from membership to help encourage more members to apply for the different Honor Awards that are available (Gold Medal, Firm Gold Medal, Mentorship Award, Public Service Award, and Emerging Professional Award). The group reviewed how the Framework for Design Excellence impacted the Design awards there were 84 submissions for the Design Awards for 2024, which is slightly lower than typical years.
- 2. Examined the format of the AIA Ohio year-in-review publication and provided feedback on how the content can be enhanced.
- 3. Reviewed the AIA Ohio Web-based Firm Directory discussed possible improvements to the format in its second year of existence.
- 4. Worked with the GAC to form an Ad-Hoc committee that examined Qualifications Based Selection best practices and shared the resulting content with the members and some outside organizations.

# AIA Ohio Sponsorship Committee Annual Report

The AIA Ohio Sponsorship Committee is a fundraising arm of the component, working to develop relationships with firms, vendors and manufacturers within the construction industry. The Sponsorship Committee works closely with the Member Engagement Committee and others in support of AIA Ohio's annual conference. Initiated during Covid-19, the committee has transformed itself from a larger group of individuals casting a wide net to a committee with a more targeted approach.

The sponsorship committee is charged with fundraising on behalf of AIA Ohio in a manner similar to the sponsorship program that occurred at previous state conferences. The change that has taken place in the last two years is that the sponsorship is a year long program that maximizes the exposure of the sponsor. New to 2024 is the change in our benefits package. The Sponsorship Committee created new opportunities for sponsors by allowing each sponsor to select their own benefits based on their level of support. This allows each sponsor to develop a recognition and marketing effort that meets their individual needs.

The Sponsorship Committee was also principally responsible for AIA Ohio's LUs & Brews at the AIA Ohio Conference held in September at Bridge Park in Dublin, Ohio. Developed for the 2023 AIA Ohio Conference, AIA Ohio worked to expand this program in 2024 with more vendors and greater learning opportunities. The LUs & Brews provided participants to earn a quarter hour of learning by meeting with each of the more than a dozen vendors to learn about materials and products. Once complete, the vendor provides each participant with a 1/2 pour of beer as they move on to the next sponsor. This was a successful event at both of the last two conferences.

Charged with gaining \$40,000 in sponsorship for 2024, the committee exceeded our goal by \$10,600, raising a total of \$50,600.

# The AIA Ohio Foundation 2024 Annual Report

The AIA Ohio Foundation has made significant strides as an organization in support of practitioners, students and the profession of architecture in Ohio. As most may know, the Foundation exists as a separate organization from AIA Ohio and, as a 50l(c)(3) organization, and accepts donations from members and others in support of the profession and the Foundation's mission, vision, and goals. In 2024, the Foundation has experienced an increase in both programs and our financial standing.

The Foundation was established to focus on providing financial support to students through scholarships. In 2024, the Foundation is continuing that work with the accredited schools in Ohio to provide scholarships to students within each of the five programs. The Foundation makes available \$15,000 each year in support of scholarships at the five schools of architecture within the state. Since 2003, the Foundation has distributed \$242,000 in scholarships to 114 students from across the state. These scholarships are a way that the profession can help those seeking to earn their architectural degree and become future leaders in the profession. Since the Foundations formation in 1968, the AIA Ohio continues to focus on supporting students.

Scholarships, however, are not the only support we provide, The Foundation continues to work with and support the American Institute of Architects Students (AIAS) chapters at each school. The AIAS, a separate entity from the AIA, supports student events and activities in the educational setting, much as AIA does within professional practices. From meetings to speakers to regional events, the AIAS supports students as they prepare to enter the profession. The Foundation assists in this effort through annual contributions to each of the five AIAS chapters in Ohio. Through grants of \$1,500 to each program, the AIAS leadership is able to advance programming that might not otherwise be offered.

In 2024, the Foundation has reviewed our grants program that was suspended in 2023. The grants application process has been reformatted and in 2025, the Foundation will reinstate the grants program with an new application and awards process. Please watch your email for more information on this popular program.

In 2024, The AIA Ohio Foundation and AIA Akron worked together to formalize an investment program that has existed between the two organizations. That agreement provides AIA Akron with the investment resources of The AIA Ohio Foundation without the need to create their own 50l(c)(3) entity. Long in the making, this agreement continues that cooperation that has long existed between these two organizations.

While continuing and formalizing ongoing programs, The AIA Ohio Foundation has taken on two new efforts this year. The first is the Student Design Awards Program. This is a joint program of AIA Ohio and the AIA Ohio Foundation. Long run by AIA Ohio, this program seeks submissions each year from students within Ohio's architectural programs. For 2024 and 2025, AIA Ohio will continue to support this effort by providing funding for this awards program. Last but not least, the AIA Ohio Foundation has established our Legacy Scholarship Program. More information on the program is detailed on the next several pages.

Finally, thank you for your support of the AIA Ohio Foundation's work. Without you, the Foundation would not exist.

#### FOUNDATION PROGRAMS

#### **SCHOLARSHIPS**

The Foundation works closely with the schools to assist students in meeting their financial obligations in the professional degree program. While we know that the amount we are able to fund is small compared to the cost of tuition, every dollar helps support those individuals who will soon be working with us side-by-side. The scholarships, in the amount of \$3,000 annually to each school, helps provide funding based on the needs of each program. The AIA Ohio Foundation allows each program to apply their own criteria to the scholarship awards. This flexibility allows each institution the opportunity to apply the funding in a way that best meets their student needs.

#### **AIAS GRANTS**

While the Foundation understands the need to help fund students directly, the organization sees a broader need to connect students with the AIA. The AIAS grant program was started to reach a wider range of students beyond the single scholarship recipient at each school. This expands recognition of the AIA brand while also assisting the AIAS chapters in meeting student needs. This program has been in place for just over five years.

#### **COMPONENT GRANTS**

The Foundation has also provided a component and affiliate organization grant program. This popular program was suspended in 2024 as the organization sought to find a better way of providing funding. The Foundation Board has revised this program and a window will soon be announce for the opening of the grants application process. As opposed to the past format, all applications will be reviewed during

one annual application window. Please watch your email for more information.

#### THE AIA OHIO STUDENT DESIGN AWARDS

As noted, the AIA Ohio Foundation has taken on the AIA Ohio Student Design Awards. Both entities agree that with the relationship between the schools and the Foundation, the Foundation is the best place to house this program. This year, the Foundation was able to recognize five projects that were part of the thirty-four projects submitted for consideration.

#### **LEGACY PROGRAM**

NEW FOR 2024! The AIA Ohio Foundation has established the AIA Legacy Scholarship program. As a means to expand our scholarship efforts, the Foundation has developed a new program that allows firms, members or any groups of individuals to support names scholarships through the AIA Ohio Foundation. With as little as \$5,000 to start, the scholarships require the donation of \$35,000 total to develop a scholarship in your groups name. This is a great way to recognize firm members, firm milestones, or just as a way to support students in architectural programs in Ohio.

#### ATA OHIO FOUNDATION PROGRAMS

#### 2024-2025 AIAS Grant Program

The AIA Ohio Foundation begins each fall semester with the delivery of checks to the architectural school AIAS program. Each school in Ohio manages and funds these student chapters in different ways, and the AIA Ohio Foundation tries to minimize the limitations we put in place for these grants. Board members team together when possible to make school visits and to provide checks to the chapter leadership. This direct connection to the programs allows the Foundation to better understand student needs and challenges.

The focus of this program is to better connect the students at the Ohio architectural schools with members of the AIA. While the AIA Ohio scholarships is a core program, the outcome of those scholarships affect only a handful of students each year. By helping fund the AIAS chapters, the AIA Ohio Foundation reaches a much broader group of individuals that AIA can connect with through the scholarship program.

#### **AIA Ohio's Grant Program**

The new AIA Ohio Grants program details are outlined below:

Eligible applicants include AIA Ohio local components, Ohio accredited architecture schools, AIAS students and student chapters, individual AIA Ohio members, and other individuals and organizations where the proposal is deemed to have a direct and positive benefit to architects and to the profession of architecture in the State of Ohio.

The AIA Ohio Foundation, in support of the profession of architecture and with a focus on its strategic goals, has set the following criteria for awarding grants:

Application submission is once a year and due August 31. Applications are reviewed by the AIA Ohio Foundation Board and awarded annually in conjunction with the AIA Ohio Design Awards. Applications received by the deadline will be reviewed in a special session held by designated members of the Board.

Awards are typically in the range of \$1,000 - \$5,000 and should not exceed \$5,000. The Board plans to allocate a benchmark amount of \$20,000 toward the support of project/programs annually. Should there be a number of compelling proposals that if funded would exceed that benchmark amount, then the Board may choose to allocate funds beyond the \$20,000 amount. Applicants may propose a minimum and maximum funding amount and should describe the project viability if the proposal is only partially funded. The AIA Ohio Foundation Board may limit the total dollar award in any calendar year.

Should a proposal be unsuccessful in a given year, the applicant may request feedback from the Board and with suggestions, can choose to revise and resubmit during a future grant cycle, but with no guarantee of funding for resubmission.

Applications are evaluated based on the merits of the project/proposal in relation to the mission and purpose of the Board. Projects with greater reach and efficacy, especially when considering equity, diversity, and inclusion within the architectural profession—as well as impact on K-12 populations—will be prioritized. Applications should describe the projects alignment with mission, purpose, and priorities of AIA Ohio Foundation.



The AIA Ohio Foundation met with the University of Cincinnati AIAS leadership on March 22, 2024 and presented the chapter with a check in support of their chapter programming. Meetings with AIAS chapters occur throughout the year at each of the five Ohio architectural programs.

from the Strategic Council

**Mission:** The AIA Strategic Council advances the architectural profession by informing the AIA Board and other Institute bodies about important professional issues, opportunities, and threats. The Council has an outward and forward-focused vision with an emphasis on long-term goals and outcomes.

#### From the Councilor

AIA National hosted "Budget Office Hours" three times in October, which is open to Strategic Councilors and National Board Members. I attended the October 15 session, which had about 35 attendees. Councilors received a national Budget Memo in advance of these office hours.

Josh Flowers, FAIA (Our current Council Vice Moderator, 2025-2026 National Secretary) voiced that the Budget Memo we received would be much better delivered paired with the Operations Plan. National (President Dowdell, and others) took that feedback well and we foresee that input is used next year. As for this year, Councilors will receive the budget plan at the same time as the Board, which is late November.

A question was raised about component revenue sharing – a question raised at our state level as well. Kevin Watkins CAE Chief Membership Officer answered this question. There is a budgeted increase for component sharing, which I shared with AIA Ohio leaders. Kevin also answered my question –The memo showed revenue from membership dues near equal from 2024 to 2025. I asked if we predict no rise in membership due to a possible recession and what recession-proof measures were taken. We sit currently at 97,000+ members and the 2025 membership goal is 104,000. While it's a goal, the Institute is being very conservative with the revenue number. Kevin shared the budget overall was developed with potential recession in mind.

President Dowdell addressed the delta in the budget – which was formerly addressed in the Annual Meeting at national conference. She reinforced that the Board was presented with very tough decisions to bring the budget down and got there.

As for Strategic Council work, all five study groups (Wellness, Equity, Climate Action, Value, have reported out to the National Board. Many recommendations were given from each group. Council Assembled on October 23 to begin to compile, prioritize the mountain of recommendations. At this meeting the results of the "Big Think" survey was shared, which was conducted by the 2025 Council Moderator, Jessica O'Donnell, AlA. Ohio got a huge shout-out as we had a large participation in this survey (14 members across the state). Thank you to those that took the survey.

My work this year on Council been with the Equity Study Group, specifically a review of the current national Code of Ethics which I conducted with Councilor Alyanna Sabayno, Assoc. AIA (Iowa). We have committed to finding a pathway to amending the current Code of Ethics with the collaboration and support of other AIA leaders and committees, such as the Equity and the Future of Architecture (EQFA) Committee.

Please contact me if you'd like to learn more about the work of Council and if there is more I can do or find out for you.

#### **Council News**

#### FROM THE MODERATOR + VICE MODERATOR

We had a busy and productive month in September, during which we elected three new at-large candidates who will begin serving on the Council starting in 2025. We encourage states and components to remind candidates who may not be elected through their representative selection process to consider applying for an at-large position on the Council next year. This is a great opportunity for those passionate about contributing to AIA's leadership. We also want to extend our gratitude to all the excellent candidates who shared their vision for the profession and their desire to work with the Council. Your passion and commitment are inspiring and critical to shaping the future of the AIA.

The Value of Architecture Study Group presented its findings to the Council, highlighting important research and recommendations on how architects create value for clients through design. A special thank you to the group for their hard work in developing and sharing this critical research. Their insights, along with the recommendations from the study group, offer valuable guidance for the profession's future growth.

The Moderator and Vice Moderator presented the work of the Council, including recommendations from all five study groups. to the Board of Directors. This year, the Board has asked the Council to prioritize these recommendations, with further updates to be shared later this year.

As we look ahead, we've begun the transition to our 2025 Council leadership. For those electing new Council members this year, please ensure you have notified AIA National of the results of your state's selection process. We have also started planning for AIA Governance Week, which will take place in December. We look forward to welcoming the new Council soon.

#### VALUE OF ARCHITECTURE STUDY GROUP REPORT

On September 25<sup>th</sup> the Value of Architecture group presented their findings to the Council. The goal of this group was for AIA members, clients, partners and communicates to understand, appreciate and pursue the value of architecture. They found that collaboration, innovation, and growth are keys to enhancing our value. One proposed innovation is an integrated virtual collaboration phase, led by the

Architect. They recommend ongoing evaluation of trends, collaboration with partner organizations, and the use of research methodologies that embrace AI technology.

#### WELLBEING STUDY GROUP REPORT

On October 15<sup>th</sup> the final study group, Wellbeing, made their presentation to the Strategic Council. The group advised on next steps following the passage of the 2024 Wellbeing Resolution. These include forming a task force to advise on implementing the imperatives of the resolution, developing a Wellbeing Resource Catalog, and encouraging the Knowledge Communities to incorporate more wellbeing topics. The group also recommended that the 2025 Council further develop case studies that could help AIA members communicate the impact of wellbeing with their clients and recommend action to celebrate schools and/or firms that prioritize wellbeing in the profession.

#### **Institute News**

#### 2023 DEMOGRAPHICS REPORT

The latest report on demographics within in the Institute is now available to download <a href="here">here</a>. AIA is committed to advancing diversity and equity in architecture and design through the intentional recruitment and retention of people with underrepresented backgrounds. The 2023 edition of the AIA Membership Demographics Report shares an overview of AIA programs and initiatives that support our diversity efforts—designing for equity and creating a sense of belonging at AIA.

#### AIA CALLS ON CONGRESS FOR EMERGENCY DISASTER FUNDING

In the wake of recent devastating storms, AIA President Kimberly Dowdell, AIA, NOMAC sent a letter to congress on behalf of the 98,000 AIA members to provide immediate supplemental funding for several federal disaster relief programs. AIA Staff has also worked to coordinate support for AIA chapters and members and connect them with resources and opportunities to lend support.

#### AIA ADVANCING CLIMATE ACTION

AIA continues to advance climate action within the built environment through cross-collaboration with industry partners and climate program milestones towards progress on building decarbonization and materials specification goals. This includes publishing the 2030 By the Numbers annual report, completing the first year of data reporting by the AIA Materials Pledge group, and participating in Climate Week NYC. #### AIA WOMEN'S LEADERSHIP SUMMIT

The Women's Leadership summit was held in Chicago October 8th-10th. The summit aims to advance equality and gender parity in the industry. The 2024 theme, "Building Resilience," challenges traditional thinking to foster positive change by exploring resilience, adaptability in a constantly shifting landscape, and perseverance during difficult times. Celebrating the 15th anniversary of the first WLS gathering, over 800 architects commemorated a significant milestone: for the first time, women make up more than one-fourth—26.8 percent—of AlA's total membership. This year also marks the second of three consecutive years with women serving as AlA national leaders, another first in the organization's history.

### "Taking Care of Business: Entrepreneurship vs Intrapreneurship" at AIA24

The Knowledge Focus Group led a 2.5-hour session at AIA'24 in DC in collaboration with the AIA Small Firm Exchange and Large Firm Roundtable. The presentation attracted over a hundred attendees and represents a nearly decade-long partnership with YAF and LFRT.



#### **YAF Redefinition**
