Legislators returned to Columbus to begin their new biennial session, the 136th Ohio General Assembly.

Members elected their separate leadership by caucus votes. The House majority Republicans chose Matt Huffman (R, Lima) as Speaker. Being newly-elected to the House after retiring as Senate President, Huffman could serve 8 years, or 4 General Assemblies through 2032.
