Jonathan Barnes, FAIA, is an innovative community activist architect. He dramatically changes communities through transformative design, adaptive preservation, social entrepreneurship, and interdisciplinary leadership.

Barnes creates new models for thriving communities and new interpretations of design in the public realm through innovative, high quality and widely awarded design. He creates platforms for public debate and engages in critical community development issues, always striving for transformational progress toward beautiful, functional, diverse, and equitable neighborhoods.

Barnes advances the national debate on the role of new architectural interventions historic environments. Barnes has pioneered an entrepreneurial housing initiative through his non-profit organization, Betterhood. The program presents a paradigm shift in affordable housing and social and financial entrepreneurship through real estate ownership, a landlord education program, and new, high-quality, rental housing. Nationally, he influences urban development and the affordable housing market through his writing and public presentations. Directly engaging with non-profit organizations, he helps achieve their goals through project-based initiatives.

Barnes's professional reach extends beyond his architectural practice. He engages with students and professionals within a broad range of land use disciplines, sharing best practices and impacting communities nationally. With his extensive knowledge of and experience with the real estate development process, he brings together the architecture and development communities across the country, initiating and generating development projects that focus on community connections and equitable public space. With his simultaneous leadership in AIA and Urban Land Institute at the local and national levels, he connects the goals, initiatives and interests of both organizations.

Barnes focuses his professional practice, his civic leadership, and his governance of the AIA and ULI organizations to transform communities, creating sustainable urban neighborhoods that are diverse and progressive, with equal opportunity for their residents.

It is my distinct hunor and pleasure to numinate Jonathon Barnes, FAIA for the 2025 AIA Ohio Gold Medal. I have known Jun Barnes for 25 years, and I have witnessed first-hand his DESKIN abilities, his respect for urban contexts, his LEADERSHIP in service to AIA and the Urban Land Institute, and his generosity in SERVICE to his community.

As his work demonstrates, ton Barnes is by far one of the very best architectural designers in the region. Under his leadership, his firm was awarded thirty-seven design awards, at all levels, Local and State Chapters, and National. His work is highly conceptual, impercably detailed, and always conscious of its urban context. Of note are his parabuilding projects, which transform existing buildings for new uses while keeping intact an original structure and its place in the city. Barnes's contributions to the community and to the profession are pointed and impactful Beyond his practice he engages with many non-profits, paving the way for professionals and students to bring good design to those entities through project-based initiatives. Barnes founded the Columbus chapter of the Urban Land Institute, creating opportunities for cross disciplinary conversation and a focus on urban conditions and opportunities. For AIA Columbus and the Center for Architecture and Design Jon has proved to be an exemplary leader, and he has been a generous, integral, and inciteful member of the Columbus Fellows Committee, providing valuable feedback to our candidates.

Finally, "Betterhood", a Barnes invention. Betterhood brings together design with social and economic amelioration in challenged neighborhoods. It is MOT gentrification. Betterhood projects provide quality, well-designed housing, equity, and opportunity for residents to own their own houses, landlord education, and the possibility of renting to a tenant—a dream come true. Create a next generation public library to serve as a valuable, collective community resource.

# Outcome

Barnes developed a library that engages the residents of an ethnically diverse and economically challenged neighborhood, supporting their pursuit of early education, lifelong learning, and a sense of community. In an open, transparent, and communal environment, the Whitehall library has become a vital community center and a technological portal to information and learning, integrating programs in early childhood reading, homework help for teens, higher education classes, and life skills for adults.

### Impa

- Regarded as a model for Vision 2020, a 10-project, aspirational library building program of the Columbus Metropolitan Library system
- Stands as a community place of pride and congregation.





### Challenge

Manifest the critical role of the public library as a place for learning, achieving, and convening through the creation of a world-class, iconic building with a focus on access, equality and inspirational design.

### Outcome

Barnes created the new Reynoldsburg Library as an open and welcoming environment with inspiring spaces both inside and out, for the Reynoldsburg community to gather, and a grand, civic scale that represents the city's value and self-worth. With a strong street presence and permeable massing, the structure embraces a public plaza as a stage for programmed events and casual encounters.

Cohort-specific interior spaces support specialized activities for young readers, teens and adults and are separately identified but interconnected for easy access. Transparent exterior envelope provides expansive views of the natural surroundings and abundant daylight.

### mpact

- Defines a new level of civic pride for a diverse and historic neighborhood as part of Vision 2020, a 20-project, aspirational library building program for the Columbus Metropolitan Library system.
- Has become a place of pride and community life.

# Challenge

Expand a historic, 100-acre working organic farm and event venue with an assembly of buildings linked through a processional path and a modern interpretion of an agrarian aesthetic true to the nature of the farm

### Outcom

Barnes created a new ceremony building defined by a heavy timber structure with a minimalist, layered pattern expressed on the facade and custom trusses inspired by traditional farm implements. A historic barn was renovated with new, modern materials, lighting and details. The collection of structures and outdoor spaces, old and new, were linked through a processional path that engages the natural environment in order to emphasize a sense of place and the immediacy of the agriculture.

### Impa

- The farrm's event venues were significantly expanded with increased functionality.
- Buildings and landscapes were reimagined with a unifying modern, minimalist and authentic aesthetic.
- The farm produces much of the food and flowers for the events on site and recycles much of the waste, creating a sustainable, semi-closed circle of production and consumption. Produce is also supplied to area restaurants and food kitchens.

Create an iconic headquarters for a new retail bank as a gateway to a historic city and a terminus to its small-scale commercial corridor.


Ohio State Bank | Modern Gateway

### Outcome

Barnes presents a modern interpretation of traditional small-scale, stand-alone branch bank typology. The bank enlivens the urban street corner with highly transparent facades that open the two-story banking lobby directly to the street, expressing the contemporary model of the retail banking business as an accessible and transparent community resource.

### mpact

- The bank has become an iconic, modern gateway is emblematic of the progressive nature of the community.
- Maximizes the capacity of the site and expands and reinforces the highly walkable, community-scaled, commercial corridor with both vehicular and pedestrian access and adjacent to city bus lines.
- Environmentally responsible through direct collaboration with the Rivers Unlimited to protect aquatic animal and plant life and maintain water quality of the adjacent Alum Creek waterway during construction and after occupancy. Disturbance of existing landscape along the waterway was minimized. The site was the subject of a Clean Ohio Fund brownfield revitalization project in order to remedy environmentally hazardous soils from a previous use.


# Outcome

Barnes created an iconic parabuilding project with the addition of 3 floors cantilevered above the exisrting concrete and masonry structure to provide 86 apartments and a ground floor cafe. The project utilizes a semi-automatic parking system on the ground floor - an innovative and critical solution that balances the needs for density and mobility.


# Challenge

Adapt a vacant urban warehouse and surface parking lot as a mixeduse residential and commercial retail project and create valuable social spaces for tenants and the public.

### Outcome

New apartments were created through a warehouse conversion and the addition of its parabuilding, a "ghost replica", and shared amenities created with an open interior lounge, a vertical exterior alley and an elevated deck conceived as an extension of the streetscape, blurring the typical boundary between public space and private space and extending the public realm into the site.

- Creates a precedent for POPOS (privately owned public open space) that is helping to shift the conventional attitude about territorial space in cities to be more open, inclusive and equitable.







Create a unified universtity neighborhood by reconnecting an isolated academic building to the heart of The Ohio State University campus. Make it the home of the College of Public Health.


### Outcome

Barnes employed the parabuilding approach expertly and effectively preserving the iconic Brutalist architecture and contrasting with his bold contemporary interventions, creating a new image for the building and for the university. A new interior concourse and entries establishes critical connections to the campus, directly linking the college to the medical school and the academic and recreational centers of the campus.





# Challenge

Renovate and expand a historic Chicago Style office building as the first large scale downtown residential project in the Columbus core.

Barnes employed the concept of parabuilding and its catalytic development potential to create an iconic addition, preserving historically and culturally significant architecture and integrating a contemporary full height addition.

- Created first major residential development in the city's urban core in nearly 20 years as part of a robust urban residential development cycle of over \$2 billion of investment that doubled the residential population in the downtown.
- Preserves a long-vacant historic office building.
- Created a hybrid aesthetic contrasting the historic architecture with a contemporary interpretation.




Downtown Residents and Housing Units 2005-2027 (includes projections) (Source: Downtown SID, Capital Crossroads SID)

# Challenge

Ignite a rejuvenation of a downtown neighborhood and preserve historic architecture through a contemporary transformation.

Mr. Barnes introduced the parabuilding concept to Columbus by creating a new image for an iconic building while restoring its historical Neoclassical presence. He led the 21st Century Columbus downtown renaissance with the Hartman Building renovation.

- Initiated the resurrection of an empty and unsafe downtown neighborhood into a prosperous commercial office hub and vibrant and popular retail scene with 18-hour activity.
- Spurred \$250 million of mixed use construction with more than 10 building renovations, 20 new businesses and 70 new residential units within 2 blocks.

Mr. Barnes was engaged by the law firm of Agostino & Assoc. PC as an expert witness to provide testimony for the Defendant in federal tax court in Del Monte LLC, Dev X Investment 2015, Tax Matters Partner Et Al, v. Commissioner of Internal Revenue, a law suit brough by the IRS against developers proposing to access federal historic preservation tax credits.

### Outcome

Using his extensive experience with successsful adaptive reuse projects, Barnes testified to the critical role of the federal historic preservation tax credit program in saving valuable historic architecture in urban neighborhoods and helping to make adaptive reuse projects economically feasible.

### **Impact**

- Sets legal precedent to allow the historic preservation tax credits to be used as intended.
- Helps to preserve important architectural history and the health and viability of historic residential and commercial neighborhoods.
- Helps revitalize and repurpose existing, often abandoned structures, creating new economic benefits.


# Outcome

Entrepreneurial Housing creates a paradigm shift in affordable housing and social and financial entrepreneurship. This concept targets the problem of absentee landlords and substandard housing in economically challenged neighborhoods with an inside out solution by creating resident landlords with a vested interest in their communities rather than by policing the offenders. This is achieved through real estate ownership, a landlord education program and new, high-quality, rental housing.


This new way of thinking replaces traditional large-scale neighborhood gentrification with a scalable infill approach that gives residents a profit and equity position with potential impact nationwide. The design consists of a "landlord residence" with income producing apartments attached.



The Bronzeville apartments converts a vacant property in a residential neighborhood of the Near East Side of Columbus to a 48-unit apartment community based upon the Entrepreneurial Housing concept and provides opportunities for neighborhood residents to own and manage real estate.

The building form and architecture are compatible with the scale of the residential neighborhood with streetfacing entries, masonry facades and a community room available for neighborhood functions.

Built initially as a conventional apartment building, the hybridownership Entrepreneurial Housing model will be implemented on a by-demand, unit by unit basis,





Barnes works closely with numerous non-profit groups, employing his professional services and expert advice to help them plan and realize projects that improve their facilities, expand their reach, and more effectively serve their communities.

### Weight of Architecture

Barnes leads AIA Columbus' Emerging Professionals in pursuit of their humanitarian goals through the chapter's programming. He formed The Weight of Architecture, an ongoing bi-annual initiative that pairs architects with non-profits to provide design services for critical projects such as a mobile music recording studio for teens and a neighborhood outdoor performance venue.

# WoA – Round I (2015)

Teams of architects joined with four non-profits – The Dick and Jane Project, Homeport, SID Public Services, Wild Goose Creative – in various architectural and landscape architectural projects. Jonathan personally led a group to assist The Dick and Jane Project, empowering students through songwriting by retrofitting a commercial freight vehicle as a mobile sound studio and performance stage.

### WoA – Round II (2017)

With four non-profits engaged – Homeport, Ohio State Bar, Clintonville Farmers Market, Goodwill Columbus – Barnes leads a group of young architects with a passion for philanthropy to create a redevelopment plan for a vacant urban lot in an economically challenged urban neighborhood in Columbus. They are creating community identity and providing a place for respite, recreation and entertainment. The lot will







Barnes led a panel of national design and real estate development experts to advise the new owners of two high-rise office biuldings in downtown Denver in the adaptive reuse of the properties for residential, hotel, office and retail uses.

The panel analyzed the real estate market including demographic trends, transportation systems, end-user market trends, and real estate development incentives, and recommended strategies for reconfiguring floors to residential apartments, co-working spaces, retail uses and building amenities. The panel also developed a financial analysis and pro forma for the project.

The owner/developer is pursuing the redevelopment project utilizing the design, development and financial reccomendations of the panel.

I am honored to write in support of Jonathan Barnes', FAIA submittal in consideration of the 2025 AIA Ohio Gold Medal Award. I have long admired his work through the many years that I have known him and have had the value and pleasure of interacting with him. This has been through AIA projects and functions, serving on juries together, and more recently through College of Fellows' activities in which Jonathan has been selfless and sought to elevate the profession. Although we did not know each other at the time, Jonathan and I shared formative years simultaneously as young architects in Boston while developing architectural sensibilities. Perhaps this is what drew me to the work of his firm which I thought exemplified intelligent, appropriate design. I found it innovative, beautiful, brilliant. Apparently, I wasn't the only one. If you go back over the last 25 years in Design Awards history, you'll find there are few years (less than 5) in which Jonathan Barnes, FAIA has not been recognized for design excellence in transformative design and adaptive preservation, by his AIA peers and just about every other organization that values good design. This was of course the basis of his election to the AIA College of Fellows a few years back in consideration of his having had a substantial impact over time and elevated the profession on a national basis.
